

## **END-USER LICENSE AGREEMENT FOR Intraclient Networks QVote**

**IMPORTANT - READ CAREFULLY:** This End-user License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity or corporation) and Intraclient Networks Inc for one (1) license to use embed into your homepage the direct link to Intraclient for use of QVote by your personnel and by visitors to your site. QVote is a web based application software includes database connectivity and other computer software and associated media. and may include "online" or electronic documentation ("SOFTWARE PRODUCT" or "SOFTWARE").

### **SOFTWARE PRODUCT LICENSE**

The SOFTWARE PRODUCT is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The SOFTWARE PRODUCT is licensed, not sold. You may use the software free for a period as defined by Intraclient and thereafter a licence fee based on each submsion of data string (question) stored on the software's database with moderate bandwidth access through your web-site.

#### **1. GRANT OF LICENSE**

This EULA grants you the following rights:

- Software. You may use and allow your web site visors to use the SOFTWARE PRODUCT, online.
- Storage/Network Use. Data generated by your use and your visitor users is stored on Intraclient server and may be accessed over the internet. A license for the SOFTWARE PRODUCT may not be shared or used concurrently on different websites.

#### **2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS**

- Limitations on Reverse Engineering, Decompilation, and Disassembly. You may not reverse engineer, decompile, or disassemble the SOFTWARE PRODUCT, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.
- Separation of Components. The SOFTWARE PRODUCT is licensed as a single product. Its component parts may not be separated for use on more than one computer.
